

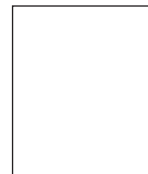
Dalton CRA Hall of Fame Nominees must exemplify the highest standards of ethical conduct and moral character.

The Hall of Fame will serve as a means of recognizing, preserving and honoring individuals who made significant contributions to the athletic programs. It honors the contributions and accomplishments of these individuals who are worthy of recognition as examples for others to emulate. All proceeds of the Hall of Fame will be used to help fund financial assistance for our youth sports programs and camperships at the CRA.
